

## SERVICE PROJECTS

### IN INDIA AND ABROAD



- ❖ Three Pre-University Colleges with vocational courses and 1 First Grade College catering to the needs of rural suburbs of Bangalore, at Bommasandra Village, Banashankari and Mysore, India from 1981 to present
- ❖ Industrial Training Institute started in 1982 at Malkote - moved to Bommasandra Village Campus, Bangalore, India in 1985
- ❖ Started a Rural Health Clinic & Maternity Hospital at Chandrappa Circle (serving about 40 villages), Magadi, TK, Karnataka, India - 1984 and 1994. Upgraded to a 30 Bed General Hospital in 2012
- ❖ Instituted Rs.1.5 Crores (\$350,000) Endowment to provide about 150 annual scholarships to needy students in India : 1987-2019
- ❖ Polytechnic Institute started in 1987 at Bommasandra, Bangalore, India
- ❖ Contributed approximately \$50,000 towards 20+ world community service projects abroad and completed them in collaboration with Rotary International - 1989-2006
- ❖ Instituted `250,000 (\$4,000) Endowment at Kannada Sahitya Parishat in India to provide annual award to a selected author and publication of his/her Book dealing with rural issues from 1994-2016
- ❖ Started Engineering Degree College at (BTLIT) Bommasandra Village Campus in 1997 - added Post-Graduate and MBA programs in 2010
- ❖ Started 3 Vidyavahini Schools (Primary, Secondary and High school) in rural parts of Bangalore and Mysore in India since 1995
- ❖ Contributed \$5,000 for the "Home for the Aged" project at Warangal, AP, India - 1999
- ❖ Raised over \$12,000 and dedicated to a Clean Water Project, the Rebuilding of Schools and to support the work of Delaware Medical Relief Team in Haiti - 2010
- ❖ Adopted 12 villages for their overall improvement, specially schools - 2009
- ❖ Donated over 3000 Books from USA to BTL Trust Institutions and Rural schools in India

### IN THE USA



- ❖ Bought and paid \$65,000 towards purchase of three buildings and deeded them to Ministry of Caring to be used for Home for Homeless / Transitional Shelter- Wilmington, DE in 2000
- ❖ Provide Holiday Meals to the needy every year since 1986. Served over 62,000 free Thanksgiving, Christmas, New Year's Day dinners and Meals on Wheels to the needy in DE, PA, MD and NJ, since 1986. Over the years, more than 14,000 meals alone have been served to Senior citizens.
- ❖ Instituted Endowment at University of Delaware to provide annual scholarships to needy Engg. students since 1990 which is now valued at \$100,000+ in 2018
- ❖ Contributed \$3,500 in scholarships (since 1997) to Delaware Technical and Community College, Newark
- ❖ Adopt-A-Highway cleaning program (both Spring and Fall) since 1995 in Delaware
- ❖ Sponsored Blind Artist Group of SRMAB (India) to perform in the USA and contributed the proceeds of \$13,000 to support SRMAB, Bangalore, India
- ❖ To develop Multi Cultural Service Center (MCSC) at Ivy House/Bechtel Park or other location - Plans Underway
